Which accident is an occupational accident?

 An event that occurs when the employee comes to the workplace with a bus/car provided by the employer and then if that car/bus has an accident, and if the employee insures physically or mentally immediately or later.

•YES, this is an Occupational accident too.



98% of workplace accidents can be prevented with some measures to be taken.

9 out of every 10 accidents occur from **unsafe behavior** . Remaining part, because of unsafe conditions consist.


If we can avoid unsafe situations and behaviors, we have also prevents work accidents

- Occupational health and safety training required must provide




WORKERS:

Accident while drinking water at the workplace

A woman fell down the stairs while taking water. The woman did not get any results at the Mainz Social Court. On the other hand, the State Social Court stated that nutrition does not cover the «insurance», but the stairs belonged to the workplace, so the incident was judged to be a work accident.

Breaking your teeth while making copies



You said «while I am copying, let me drink some beer». The beer suddenly frothed and your tooth was broken as you tried to inhale it. Is this a work accident? Dresden Social Court says 'No'. Nutrition is not covered by «insurance» and copying is not a job that requires much drink.





In Trabzon, the municipal worker cleaning the manhole was severely injured when a car was passing by when he pulled his head out of the manhole hole.

Examples for Occupational Accidents in Turkey

• The iron and steel factory worker passed through a 600-tonnes press machine, tried to burn his cigarette in a 2450 centigrade oven and lost his life by burning. (Karabük Iron and Steel Factories)



Examples for Occupational Accidents in Turkey

• Closing the cover while the ship's engineer was checking the boiler and lost his life by staying in the caulder's ship. (Kocaeli)
