- f) Transport the vaccines they have received in accordance with the procedures, preserves and maintains refrigerators in their holdings for storage purposes.
- g) The documents related to the practices carried out by the provincial directorate shall be submitted.

SECTION FOUR

Disease Control

Application in protected areas

ARTICLE 26 - (1) The Ministry may prohibit or restrict the entry of certain animal species into the designated protected area in order to prevent the occurrence of harmful organisms in which the animal is destroying or destroying in one or more regions.

- (2) The animals shipped to the protected areas, which are established for some animal species in the scope of the fight against animal diseases by the Ministry, except for the procedures and principles determined by the Ministry, are referred to the direct slaughterhouse at the nearest slaughterhouse, at the expense of the owner.
- (3) All animals in animal husbandry establishments in protected areas determined by the Ministry free of disease must be registered in the Ministry database. The animals not registered in the Ministry database shall be referred to the protected area except the procedures and principles determined by the Ministry and shall be referred to the slaughterhouse at the nearest slaughterhouse at the owner's expense.

Obligation of local administrations

ARTICLE 27 - (1) Special provincial administrations and municipalities have to put in sufficient amount of appropriations and participate in the struggle in their budgets each year, taking into account their financial means and animal assets to combat animal diseases.

- (2) Ministry or provincial directorate of the Ministry in the fight against the program, or outbreak epidemic and infectious diseases necessary to extinguish the disease, drugs, tools, disinfectants, materials and transportation costs, which are required to work temporarily, personnel expenses and fuel costs according to the budgetary budget of the special administration and municipal budgets reports the need for a civil administration officer to be provided. The local administrative authorities are obliged to ensure that the special administrations and municipalities participate in the fight against animal diseases to the extent of their financial means.
- (3) Animal health care committee will determine the way of special administration and municipalities to participate in the fight against animal diseases. Special provincial administrations and municipalities are obliged to participate in the efforts to extinguish the financial means, means and personnel and the disease in cases of rabies.

Animal health advisory commission

ARTICLE 28 - (1) Animal Health Advisory Committee, which consists of members to be elected by the Ministry under the presidency of the Minister of Food, Agriculture and Livestock or Undersecretary, may be established. According to the issues to be examined in the Commission, representatives of universities, public and private sector and professional organizations can also be appointed as members of the commission. The General Manager of Food and Control carries out the secretariat of the board.

Animal health police commissions

ARTICLE 29 - (1) In order to protect animal health, to combat infectious animal diseases, to determine the measures of animal movements in the country and to the transport of animals and substances and to ensure the implementation of the animal health police commissions are established with the participation of the following members.

- a) Provincial animal health police commission; under the chairmanship of the governor or the deputy governor to be appointed, the mayor, provincial police director, provincial gendarmerie commander, heads of chambers of commerce and agriculture, provincial health director, ministry provincial director, animal health, breeding and aquaculture branch manager, member of provincial council and trade exchange Head of Commodity Exchange and an Official Veterinarian
- b) The county animal health police commission; head of district governor, district police chief, district gendarmerie commander, district health group head, district director, official veterinarian and head of the chamber of agriculture,
- c) Commission on animal health police; under the chairmanship of the official veterinarian, the mayor of the town and the headmen of the neighborhood, ç) Village animal health police commission; under the chairmanship of the official veterinarian, the village headman, the elder committee and the guard or guard of the village.

- (2) Procedures and procedures for gathering and decision-making of animal health police commissions are as follows.
- a) Animal health police committees are called upon by the chairman to discuss the proposal of the official veterinarian on the disease exit report or the provincial / district director's proposal at the exit of one of the compulsory diseases.
- b) The decisions of the Animal Health Committee are taken by majority of votes. No abstaining vote. In the equality of votes, the decision is taken in accordance with the votes of the commission chairman. The issues concerning the implementation of the decisions of the Commission shall be inspected by the official veterinarian.
- c) In order to participate in the Local Appraisal Commission established to determine the compensation to be paid to the producer within the scope of the diseases to be paid compensation, one of the members of the provincial or district animal health police commission is appointed by the governor / deputy governor or district governor depending on whether the disease is in the province or district.

c) Animal health police committees report to the upper animal health police commission the requirements and requirements which cannot be made by the local authorities. Provincial animal health police commission is the highest commission.
