DECISION REGULATION IN ANIMAL DISEASES

Purpose

ARTICLE 1 - (1) The purpose of this Regulation is; Within the scope of combating animal diseases, to determine which animal diseases included in the ları Regulation on Compensation for Animal Diseases and Compensation em, which was put into force with the decision of Council of Ministers dated 25/11/2011 and no.

Scope

ARTICLE 2 - (1) This Regulation covers the procedures and principles related to the slaughter, culling and destruction processes to be applied to the animals and the payments to be made to the pet owners due to the compensated animal diseases.

Rest

ARTICLE 3 - (1) This Regulation has been prepared on the basis of Article 5 of the Veterinary Services, Plant Health, Food and Feed Law No. 5996 dated 11/6/2010.

Definitions

- **ARTICLE 4** (1) In this Regulation
- a) Ministry: Ministry of Food, Agriculture and Livestock,
- b) Animal: vertebrate and invertebrates, including aquatic animals,

c) Animal owner: The natural or legal person holding the property rights of animals,

ç) Animal products: All animal products including animal food, animal byproducts and reproductive products offered to human consumption,

d) Heat treatment: Process which causes negative reaction in alkaline phosphatase test immediately after any application involving heating, except boiling,

e) Official laboratory: Veterinary diagnostic and analysis laboratories, which have been granted work permits by the Ministry,

f) Official veterinarian: The veterinary staff of the Ministry, acting on behalf of the Ministry,

g) Compensation: The price to be paid for the destruction and disinfection of the products and equipment decided to be disposed of due to the disease and the animals decided to pay compensation for the compensated diseases,

i) Authorized veterinarian: veterinarian authorized by the Ministry to carry out the official duties to be given, except for veterinarians in the Ministry,
Expresses

Compensation diseases

ARTICLE 5 - (1) Ruam, bovine tuberculosis, bovine brucellosis, sheep and goat brucellosis, bovine plague, African horse sickness, avian influenza, false chicken pest (newcastle disease), rabies and foot disease the owners of animals shall be compensated according to the principles stated below.

When making appraisals of race horses, the value of breeder and racehorse is not taken into consideration. Appraisal is made as horse cost. a) Three-quarters of the appraisal values of unrecognized animals determined to have suffered from glanders as a result of mallein test or bacteriological and serological examination,

b) Nine tenths of the appreciation of cattle, who have been diagnosed with bovine tuberculosis at the end of the application of the tuberculin test,

c) Three-fourths of the value of the cattle carcasses determined in the slaughterhouse after the slaughter of cattle tuberculosis,

ç) Cattles determined to be infected with bovine brucellosis by serological or bacteriological examination, and nine to ten tenths of sheep and goat's sheep and goats, which are found to be infected with sheep and goat brucellosis, d) the appreciation of the cattle and horses that have been diagnosed and killed at the end of the laboratory examination or because of the obvious symptoms of the disease in bovine plague and African horse sickness,

e) all of the appraised assets of birds killed in avian influenza disease, because of suspicion of the disease or after the presence of disease in the laboratory,

f) Three-quarters of the assets to be appreciated for the animals killed in the operation in which the animals belonging to the animals with detected poultry (newcastle disease) at the end of the laboratory examination,

g) four-fifths of the cattle, sheep and goats killed in cattle, sheep and goats bitten by the animal identified with rabies disease and the cattle, sheep and goats killed in the animal husbandry establishment which is infected with the disease, ğ) (1) All of the appraisal assets of the animals susceptible to the foot-andmouth disease that have been killed or predicted after being identified by the laboratories or by the laboratory due to the obvious symptoms of the disease in the areas determined by the Ministry in foot-and-mouth disease, paid as compensation.

(2) In the cases of the first paragraph, the meat, leather and other parts of the animals that are consumed and consumed are deducted from the compensation they deserve.

(3) The determination of bovine brucellosis, sheep and goat brucellosis, false chicken plague and rabies diseases by the official laboratories from the diseases of the first paragraph, and the determination of other diseases by the official veterinarian, authorized veterinarian or official laboratories is essential for compensation compensation. Samples taken for diagnosis of diseases are taken by the official veterinarian and sent to laboratories by official letter.

Confiscation, slaughter, culling and destruction of animals

ARTICLE 6 - (1) The animals that are caught in the compensatory diseases mentioned in this Regulation or who are suspicious of the disease are confiscated by the Ministry to pay the compensation and the maintenance costs shall be delivered to the owner as the trustee by the owner.

(2) In order to prevent the spread of animal diseases and to protect public health, the Ministry decides on slaughtering, culling or annihilating animals that are caught in compensated diseases specified in this Regulation or who are suspected of compensatory disease. However, if the owners of rabies, bitten by the rabid animal or the owners of the disease do not consent to the killing of their animals, the cattle shall be quarantined for six months, the sheep and the goats shall be kept in quarantine for the duration of the quarantine for three months.

(3) The animals caught in compensatory diseases and the suspected animals, which the Ministry deems appropriate to be discontinued, are estimated within thirty days. If the appropriate location cannot be found within this period, the Ministry shall be culled and destroyed by the Ministry.

Compensation of animal products, feed, materials and materials

ARTICLE 7 - (1) The costs of animal products, feed, materials and materials as well as the costs of destruction, transportation and disinfection shall be paid as compensation to their owners as specified below, on the amounts determined by the local appraisal commission.

a) The costs of all animal products, feed, materials and materials destroyed by the diseases of Ruam, rinderpest, horse sickness, bird flu, pest control (newcastle disease) and the costs of destruction, transportation and disinfection;

b) All costs of feed, materials and materials, as well as destruction, transportation and disinfection costs of other animal products, other than milk, in screed, bovine tuberculosis, bovine brucellosis, sheep and goat brucellosis,

c) The costs of food, materials and materials destroyed and the costs of destruction, transportation and disinfection in rabies,

paid as compensation.

(2) The products of bovine, sheep and goats bitten by the animal caught in rabies or suspected of disease and the products of these animals shall be destroyed for the protection of public health. However, if the owners do not consent to the killing of the cattle, sheep and goats are quarantined for six months, sheep and goats are kept for the duration of the quarantine period.
